In computing your expenses, you should bear in mind that those students holding Student (F) visa will not be authorized to work except under extraordinary circumstances. Therefore, the applicant should not look to employment, either part-time during the academic year or full-time during the summer, as a significant means of support while at St. Andrews. Spouses of F-1 student visa holders are not permitted to work under any circumstances.
